Notice to Members

Dear Members,

The Home Affairs Bureau (HAB) launched a six-month public consultation on the recommendations of the policy review on Private Recreation Leases (PRL) in March to September 2018. Following a consultation process, the Club made a submission in response to the Home Affairs Bureau in September 2018 to include social services as a factor in granting lease renewals.

The Home Affairs Bureau (HAB) reported the outcome of the public consultation to the Panel on Home Affairs of the Legislative Council in February 2019 and unfortunately HAB reiterated sports contribution is the only factor in granting lease renewals. A Circular to members had been posted in the same month. (A copy of the circular is attached for ease of reference).

Our Club has revised the Sports Membership Scheme and continued to engage professional consultancy firm to assist in collaboration with National Sports Associations (NSAs) and Eligible Outside Bodies (EOBs).

Regarding the Sports Membership, we have received 5 applications in the tennis category, 2 applications in the table tennis category and 10 applications in the badminton category until now. Following the approval process, 3 tennis players were approved. They had represented the Club in the last few matches and had made great contribution with good results. 2 table tennis applicants will be interviewed soon, and the 10

badminton players will be reviewed later at an appropriate time until the Club has formed a badminton team to join competition using the Club badminton courts.

Our professional consultancy firm, AsiaNet Communication Ltd had looked for on our behalf National Sports Associations (NSAs) and Eligible Outside Bodies (EOBs) and introduced to us 'HK Judo Association' and 'Chan Shu Kui Memorial School'. The total usage hours of 'HK Judo Association' was 14 hours (since July 2019) and 'Chan Shu Kui Memorial School' was 12 hours (since May 2019).

Our Management Team have also continued to partner with Eligible Outside Bodies (EOBs) and we have collaborated with 5 new EOBs since May 2019, mainly with the Schools registered under the Education Ordinance which include 'Heung To Middle School', 'Our Lady of The Rosary College', 'Concordia Lutheran School', 'Chan Shu Kui Memorial School' and YMCA. Some of them have started to put a trial use of our sports facilities since May 2019 and we are waiting for the schools to form their own sports teams and finalize the yearly schedule on using our sports facilities.

Eligible Outside Organizations fall under five categories:

- Schools registered under the Education Ordinance;
- National sports associations recognized by the Sports Federation & Olympic Committee of Hong Kong, China and relevant International Federations;
- Uniformed groups and youth organizations receiving subvention from the Home Affairs Bureau;
- Non-Governmental Organizations receiving subvention from the Social Welfare Department; and
- Government departments.

A full list of Eligible Outside Bodies (EOBs) is at the Annex (Attached).

Our Club currently has Dining Membership. However, the Government mentioned the following in the consultation paper 3.3.18.

'The Working Group also proposes to require PRL lessees which are private sports clubs to allow non-members access to essential supporting facilities such as toilets, changing rooms, drinking fountains and "pro shops" selling sport-related goods, such as equipment, medical supplies and sports nutrition items. As regards their use of other ancillary facilities such as F&B outlets, we may consider supporting arrangements where the use of such facilities by non-members is incidental to their use of sports-related facilities. The Working Group does not however see a justification for allowing the private sports clubs to open up their F&B outlets to non-members who are not users of the sports facilities as this is tantamount to allowing the private sports clubs to operate such outlets commercially, which contravenes the original intent of PRLs in providing services to their members and results in unfair competition with F&B outlets operating on private leases that are subject to full market premium."

Also, as per our Club General Manager, Mr Simon Ho's conversation in April 2019 with HAB, HAB does not recommend the Club to open up their F&B outlets to non-members. The Membership and Promotion Sub-Committee therefore has reached a decision for deletion of Dining Membership in July 2019 and is awaiting final approval from General Committee.

Dear Members,

You may have learnt from various news and social media that the Home Affairs Bureau has published its report on the responses to the private recreation leases policy consultation paper it received during the consultation period last year.

Despite recognition of receiving proposals that Government should also take into account of private recreational clubs' non-sports contributions to society such as charity work, the Home Affairs Bureau report indicates that contribution to sports development of Hong Kong is the only criteria adopted by Government when considering renewal of such leases.

Proposals put forward in the consultation paper will be adopted except the proposal of charging one third full market value of the land. The excepted proposal will be reconsidered because of opposition from stakeholders and the major public user, the National Sports Association.

Much emphasis has been put on further opening up of the sports facilities to the public though "public" means eligible bodies set out in a list provided by the Home Affairs Bureau and further partnering with National Sports Associations (NSAs). Members of the public have warned against "fake opening up" and urged the Government to require opening up of peak hours as well.

Our club naturally has to use its best endeavours to follow proposals adopted by Government in order to be favourably assessed by it when it is nearer the time of expiry of the club's lease in 2026 but actions must be taken as soon as possible given the time required for planning and implementation.

The PRL subcommittee and the Recreational subcommittee will, with the assistance of professional consultant, determine how best to position the club in the next few years while at the same time balancing all members' interest. The club was not designed as a club specialising in any particular sports so there are basic constraints against us.

I sincerely hope that solutions can be worked out to enable the club to contribute further and significantly to the sport development of Hong Kong and at the same time without the need of compromising members' use of the club's facilities to an unbearable extent.

I will report further and periodically after the two subcommittees have worked out solutions.
