有關又一村花園俱樂部就個人私隱專員公署報告之回應

就今日個人資料私隱專員公署（下稱「公署」）發布之調查報告，又一村花園俱樂部（下稱「本俱樂部」）表示完全尊重並採納公署的建議。在事件調查期間，本俱樂部一直與公署保持溝通並積極配合，目前本俱樂部已根據公署報告的要求，積極實施各項維護私隱安全的改善措施。同時，是次事故對會員帶來的憂慮我們深表遺憾，並向會員再致以誠摯歉意。

自事故發生後，本俱樂部已即時跟進及執行各應對行動，包括透過短訊及官方網站通知受影響的會員、向警方報案及向公署通報。同時，本俱樂部已即時停用涉事的遙距存取軟件，並全面升級網絡防護設備，包括對個人資料檔案進行加密，以及實施嚴格的授權與監察機制。根據目前監察得知，至今尚未發現任何受影響的資料被公開。

針對資料保留期限，過往部分資料乃基於財務審計及行政用途而保留。本俱樂部正積極落實更嚴謹的資料保留及銷毀政策，確保嚴格遵守《私隱條例》的規定，不再保留非必要或超過法定要求之個人資料，以最大程度降低風險。

本俱樂部將持續強化網絡保安，致力維護會員的私隱安全。

Statement from Yau Yat Chuen Garden City Club
Regarding the PCPD Investigation Report

Regarding the investigation report issued today by the Office of the Privacy Commissioner for Personal Data (the “PCPD”), Yau Yat Chuen Garden City Club (the “Club”) expresses its full respect for and acceptance of the PCPD’s recommendations. Throughout the investigation, the Club has maintained close communication and actively cooperated with the PCPD. Currently, the Club has been proactively implementing various improvement measures to safeguard privacy and security in accordance with the requirements set forth in the PCPD’s Enforcement Notice. Meanwhile, we deeply regret any concern caused by this incident to our members and extend our sincere apologies again to the affected.

Since the occurrence of the incident, the Club has taken a series of immediate actions, including notifying affected members via SMS and our official website, reporting the case to the Hong Kong Police Force, and notifying the PCPD. Simultaneously, the Club immediately deactivated the remote access software involved and has since undergone a comprehensive upgrade of its network defense infrastructure, including the encryption of personal data files and the implementation of rigorous authorization and monitoring mechanisms. Based on our continuous monitoring to date, there is no evidence to suggest that any affected data has been disclosed to the public.

Regarding the matter of data retention, certain records were previously retained for financial audit and administrative purposes. The Club is currently in the process of implementing a more stringent data retention and disposal policy. This ensures strict compliance with the *Personal Data (Privacy) Ordinance*, whereby personal data that is no longer necessary or exceeds statutory retention requirements will not be kept, thereby minimizing potential risks.

The Club remains committed to continuously strengthening its cybersecurity measures and safeguarding the privacy of our members.
