網絡安全事件最新進展及私隱專員公署結案通知

俱樂部謹就早前發生之電腦系統遭受外部入侵一事，以及個人資料私隱專員公署（下稱「私隱專員公署」）於四月發出之執行指令，向會員匯報最新進展。

上月，我們接獲私隱專員公署的正式信函。公署於信中表示，對於俱樂部在網絡安全事件後所採取的應對行動及系統優化措施感到滿意，並於信中正式確認各項合規要求與安全標準均已全面落實。基於上述結果，私隱專員公署現已正式將此案件結案。

自事件發生以來，俱樂部已積極進行一系列系統升級及保安強化措施，並委任香港生產力促進局（HKPC）作為獨立第三方顧問，進行全面系統及政策審查。在專業團隊的協助下，我們已大幅提升網絡基礎設施，全面完善內部資料管理政策，並確保嚴格遵守相關要求及守則，從而將潛在風險降至最低。

Update on Cybersecurity Incident and PCPD Case Closure

The Club would like to provide an update regarding the unauthorized access to our computer systems that occurred earlier this year, as well as the subsequent Enforcement Notice issued by the Office of the Privacy Commissioner for Personal Data (the "PCPD") in April.

Last month, we received an official letter from the PCPD expressing their satisfaction with the response actions and system optimizations the Club has undertaken following the cybersecurity incident. The letter formally confirms that the Club has fully implemented and met all compliance requirements and security standards set forth by the PCPD. Based on these findings, the PCPD has officially closed the case.

Since the incident, the Club has proactively implemented a series of system upgrades and security enhancements. Furthermore, we appointed the Hong Kong Productivity Council (HKPC) as an independent third-party consultant to conduct a comprehensive assessment of the Club systems and policies. With the assistance of their expert team, we have significantly elevated our network infrastructure and thoroughly refined our internal data management policies. These measures ensure strict compliance with relevant requirements and codes of practice, thereby minimizing potential risks to the greatest extent possible.

The Club will continue to monitor and elevate our cybersecurity standards to ensure that members' personal data is properly handled and securely stored. We sincerely appreciate your understanding and support. Should you have any enquiries, please do not hesitate to contact us at 2397 4311.
